**Eleni Bastéa** was born and grew up in Thessaloniki, Greece. She holds a BA in Art History from Bryn Mawr College, US, and an MA of Architecture and a PhD in Architectural History, both from the University of California at Berkeley, US. She teaches at the University of New Mexico, US, where she is Regents' Professor of Architecture and Director of the International Studies Institute. Bastéa's books include *The Creation of Modern Athens: Planning the Myth* (Cambridge University Press 2000), also published in Greek (Libro 2008), *Memory and Architecture* (University of New Mexico Press 2004), and *Venice without Gondolas*, a poetry collection (Finishing Line Press 2013).

**Evangelos Hekimoglou** is Principle Curator of the Jewish Museum of Thessaloniki (former Director of the National Bank of Greece/Cultural Center for Northern Greece). He studied at the Aristotle University, Thessaloniki, Greece, and holds a PhD from the same university ('The historical and Spatial Nature of the Economic Surplus'). He has published more than a hundred articles and thirty books on the history of Thessaloniki and the economic history of the Ottoman and the Greek states.

**Charis Christodoulou** is Assistant Professor at the School of Architecture, Aristotle University of Thessaloniki (AUn), Greece. She holds a PhD in Planning from the Department of Urban and Regional Planning and Development, AUn. She has worked as a professional architect-urban designer and a consultant to local authorities on urban strategies, and has written on housing issues and social exclusion, urban design and public space, urban planning and socio-spatial transformations.

**Sotiris Dimitriadis** is a historian of the late Ottoman Empire, with a special interest in urban and social history. He completed his PhD dissertation at the Department of History at SOAS-University of London, UK, and is currently Post-Doctoral Fellow at the Department of Balkan, Slavic and Oriental Studies of the University of Macedonia, Greece.

**Edhem Eldem** is Professor in the Department of History of Boğaziçi University, Turkey, and holds the International Chair of Turkish and Ottoman History at the Collège de France. His fields of interest include the Levant trade, funerary

**Eyal Ginio** is Associate Professor in Middle Eastern and Islamic Studies at the Hebrew University of Jerusalem, Israel, and Director of the Ben-Zvi Institute for the Study of the Jewish Communities in the East. He holds a doctorate from the Hebrew University. He has published numerous articles on the social and cultural history of Salonica during the Ottoman period and following the transition to Greek rule and on the Balkan wars. He is currently preparing a study on the modernization of the Ottoman Sultanate after the 1908 revolution.

**Basil C. Gounaris** is Professor of Modern History in the Department of History and Archaeology at Aristotle University of Thessaloniki, Greece. He studied History at the Aristotle University (BA, MA) and holds a DPhil from St. Antony's College, Oxford, UK. He has edited and published numerous books and articles on Modern Greek, Balkan, and Mediterranean History. Two of his monographs won awards from the Academy of Athens.

**Vilma Hastaoglou-Martinidis** is Professor Emerita of Urban History and Design at the School of Architecture, Aristotle University of Thessaloniki, Greece. She holds a degree in Architecture and a PhD in Urban Planning from the School of Architecture, Aristotle University of Thessaloniki, and a Diploma in Urban Sociology from the École des hautes études en sciences sociales, Paris, France. Her research interests include planning history, urban modernization, and heritage preservation. She is the author of many books on urban history and planning in Greece and the Eastern Mediterranean. She is currently working on a book, *Harbor Building and the Modernization of the East Mediterranean Cities in the Late 19th Century*.

**Eleni Kallimopoulou** is Assistant Professor in Ethnomusicology at the University of Macedonia, Greece. She received her PhD in Ethnomusicology from the School of Oriental and African Studies (SOAS), University of London, UK. She is author of the book *Paradosiaká: Music, Meaning and Identity in Modern Greece* (Ashgate 2009), and co-editor of *Introduction in Ethnomusicology* (Asini 2014). Her research interests center on Greece and the Mediterranean; musical performance and ethnography; public folklore and the politics of culture; nationalism, religion, and ritual; oral history; and auditory culture and urban space.

**Konstantinos Katerinopoulos** is a lawyer and economist based in Athens. He has studied and written on refugee resettlement issues in Greece.

**Dimitris Keridis** is Professor of International Relations at Panteion University of Athens, Greece. As of July 2019, he is an elected member of the Greek Parliament, representing Athens-North for center-right New Democracy. He directs the Olympia Summer Academy in Politics and International Studies ([www.olympiasummeracademy.org](http://www.olympiasummeracademy.org)) and the Navarino Network, a public policy think-tank based in Thessaloniki ([www.navarinonetwork.org](http://www.navarinonetwork.org)). He is a senior fellow at the Konstantinos G. Karamanlis Foundation. He has been a regular political commentator and host of a weekly TV show on foreign affairs. Past positions include senior consultant at the Greek Ministry of Foreign Affairs, the Constantine Karamanlis Associate Professor in Hellenic and European Studies at the Fletcher School, director of the Kokkalis Foundation in Athens, director of the Kokkalis Program on Southeast and East-Central Europe, and adjunct lecturer at the John F. Kennedy School of Government, Harvard University.

**John Brady Kiesling** is an archaeologist and former U.S. diplomat, whose work includes *Greek Urban Warriors* (2014), *Diplomacy Lessons* (2007), the ToposText application, and various edited works on Greek history.

**Paschalis M. Kitromilides** obtained a PhD Harvard University, USA, and is Professor Emeritus of Political Science at the University of Athens, Greece, and Director of the Center for Asia Minor Studies. From 2000 to 2011, he was Director of the Institute of Neohellenic Research at the National Hellenic Research Foundation. He has held visiting appointments at Cambridge and Oxford, the École des hautes études en sciences sociales, the European University Institute and the Harvard Center for Renaissance Studies, Villa I Tatti, Florence. His books in English include: *The Enlightenment as Social Criticism*; *Iosipos Moisioudax and Greek Culture in the Eighteenth Century*; *Enlightenment Nationalism Orthodoxy*; *An Orthodox Commonwealth*; *Symbolic Legacies and Cultural Encounters in Southeastern Europe*; *Enlightenment and Revolution. The Making of Modern Greece* (Harvard University Press 2013); and *Enlightenment and Religion in the Orthodox World* (Voltaire Foundation 2016).

**Yura Konstantinova** is Associate Professor in the Institute of Balkan Studies, Center of Thracology at the Bulgarian Academy of Sciences. She studied History and Greek philology at the Sofia University, Bulgaria, ‘St. Kl. Ohridski’ and holds a doctorate from the Institute of Balkan Studies, Bulgarian Academy of Sciences, on the topic ‘The Balkan policy of Greece at the end of 19th and the early 20th century’. She has published numerous articles on Modern and Contemporary Balkan History, Greek-Bulgarian Relations, Political Propaganda, and is currently preparing a study about Bulgarian community in Thessaloniki in the end of nineteenth and the early twentieth centuries.

She has published numerous articles on the history of the cities of the Ottoman empire and is currently preparing a study on the civic sphere in an Ottoman urban context.

**Philip Mansel** is Fellow of the Royal Historical Society and the Institute of Historical Research, London. He studied History and French at Balliol College, Oxford, UK, and received his PhD from the University of London, UK, in 1978. His books include histories of Constantinople City of the World's Desire and Smyrna, Alexandria, and Beirut (*Levant: Splendour and Catastrophe on the Mediterranean*). He is one of the founders of the Society for Court Studies ([www.courtstudies.org](http://www.courtstudies.org)) and is a founding trustee of the Levantine Heritage Foundation ([www.levantineheritage.com](http://www.levantineheritage.com)). In 2016, he published a short history of Aleppo. He is currently preparing a biography of Louis XIV.

**Mark Mazower** is Ira D. Wallach Professor of History at Columbia University, US. He studied classics and philosophy at Oxford, and international affairs at Johns Hopkins and he holds a doctorate in history from Oxford. His books range on topics from Salonica (*Thessaloniki City of Ghosts*) to international governance and he recently finished a family memoir, entitled *What You Did Not Tell* that has been published in Greek by Agra.

**Devin E. Naar** is Isaac Alhadeff Professor in Sephardic Studies and Associate Professor of Jewish Studies and History at the University of Washington in Seattle, US, where he directs the Sephardic Studies Program and is a member of the Hellenic Studies faculty. Naar received his PhD in History from Stanford University, US, in 2011 and was a Fulbright Scholar in Greece. His book, *Jewish Salonica: Between the Ottoman Empire and Modern Greece* (Stanford University Press 2016), won the 2016 National Jewish Book Award for Best Archival Research and the 2017 Keeley Prize for best book in Greek studies awarded by the Modern Greek Studies Association.

**Olivia Pallikari** is a PhD student at the faculty of Theater Studies—School of Philosophy at the National and Kapodistrian University of Athens, Greece. She

studied at the Faculty of German Language and Literature at the University of Athens and did her MA at the Faculty of Theater Studies. She has worked as Lecturer of Semiotics at the same program and as Lecturer of Theater History in several acting schools. She has taken part in several conferences and has written articles about the history of theater in the Greek press.

**Spyridon G. Ploumidis** is Assistant Professor in Modern Greek History at the National and Kapodistrian University of Athens, Greece, in the Department of History and Archaeology. He studied History at the Ionian University, Corfu, and holds a PhD from the University of London, UK (his PhD thesis was on ‘Ethnic symbiosis and friction between Greek Orthodox and Bulgarians in Plovdiv/Philippoupolis, 1878–1906’). **Panagiotis C. Poulos** is Lecturer in the Arts of Islamic World at the Department of Turkish and Modern Asian Studies, National and Kapodistrian University of Athens, Greece. He studied ethnomusicology with a focus on the musical traditions of the Near and Middle East at the School of Oriental and African Studies at the University of London, UK, where he also completed his PhD dissertation on Ottoman classical music. His publications center on cultural history of late Ottoman and Turkish music and arts, and the history of everyday life in Ottoman cities. He is currently scientific coordinator (with E. **Kornilia Trakosopoulou-Tzimou** is former Director of the Ministry of Culture and Sports and Lecturer at the Democritus University of Thrace, Greece, in the Department of Architecture. She pursued her postgraduate studies at the School of Specialization in Restoration of Monuments and Sites at the same university and later on at the University of London—Faculty of Science—Bartlett School of Architecture and Planning, UK. **Athena Yiannakou** is Associate Professor in Urban Policy and Urban Development at the School of Spatial Planning and Development, Aristotle University of Thessaloniki, Greece.
